



WGBC is not able to give specific direction regarding shipping wine out of the country due to the legalities and the complexities of the process. Below is a top level guide for you to begin with, based on WGBC's experience shipping wine samples to USA and international wine competitions and trade/media events.

It is important to educate yourself regarding the complete process and requirements for shipping wine samples and/or wine for sale and/or for other types of events (including consumer facing, etc.). It is the shipper's responsibility to know and comply with all applicable international laws and regulations.

Shipping BC Wine SAMPLES to USA for Trade/Media Facing Events & Competitions Note: Given the three-tier system of USA alcohol distribution, it is crucial to look for further information if shipping wine to the USA for consumer facing events and/or for sale.

- 1. Visit and understand: www.ttb.gov/itd/importing-samples.
- 2. You must have an FDA Food Facility Registration (previously called bioterrorism number), obtainable at
  - www.fda.gov/Food/GuidanceRegulation/FoodFacilityRegistration/default.htm
    - a. Prior to getting your FDA number you will require a US FDA agent and a US importer of record (who can file for you).
- 3. Once you are ready to ship your SAMPLES, provide your pro forma commercial invoice (includes winery information, wine quantity, bottle size, type and alcohol content, etc.; see <a href="sample">sample</a>) and direct each of your agents to perform various tasks, such as (not exhaustive):
  - a. shipping agent pre-customs clearance & physical shipment, etc.
  - b. importer of record files request for COLA waiver (refer to TTB website), etc.
  - c. customs broker pre/post-customs clearance (including prior notification), etc.
- 4. Every bottle (yes, BOTTLE!) must be labelled with the required "health warning statement".

## Shipping BC Wine SAMPLES to European Union

Note: WGBC does not have experience/information regarding shipping wine for sale.

- 1. - 2. Each wine may require an originally executed VI-1 Export Form. Contact the <u>BC Wine</u> Authority for the appropriate form and procedure.
  - a. Conflicting information has been provided by various companies and regulators regarding the VI-1 requirement, particularly related to the quantity of shipment and related to shipping of commercial samples. In WGBC's experience, it is best to obtain the VI-1 Export Forms to ensure clearance.
- 3. The UK may also require you to have an EORI number: www.gov.uk/eori
- 4. Once you are ready to ship your SAMPLES, provide your pro forma commercial invoice (<u>sample</u>) and direct each of your agent(s) to perform various tasks, such as (not exhaustive):

   (e.g. other countries require certification of origin of wine export forms, such as VI-1 Export Form.)
- 2. Once you are ready to ship your SAMPLES, provide your pro forma commercial invoice (<u>sample</u>) and direct each of your agent(s) to perform various tasks, such as (not exhaustive):
  - a. shipping agent pre/post-customs clearance & physical shipment, etc.
