PLACE

In the Burgundy wine producing region of France In viticultural.

PARTICIPANTS

Every country and all French regions.

PRODUCTS

Wines produced **exclusively from Chardonnay grape**.

Up to **5% of non-aromatic varieties** (e.g. Pinot blanc, Maccabeo) is allowed. However, the presence of aromatic varieties (e.g. Muscat, Muscat-like varieties, Gewurtztraminer, Chenin blanc, Viognier, etc.) or of varieties that modify wine structure (e.g. Pinot noir) is not authorised, and any wines containing such varieties shall **be excluded from the competition**.

The amount of the wine available should be **at least of 1300 bottles** (for specific winemaking process contact us) and conditioned under glass and recognizable by lot.

COMPETITION RULES

International Wine competition Standard.

PARTICIPATION RULES

- **6 bottles of 750 ml or 10 bottles of 500 ml or 375 ml** (with front and back labels)
- **A technical sheet** dedicated to presentation including: development, area of growth, maturity of wine, density of plantation, grape harvest, wine making (barrel or tank), maturation of wine...
- **An analysis bulletin dated less than one year**. It must specify the parcel number as well as the following results: actual and potential alcohol content, reducing sugar, total acidity, volatile acidity, free SO₂, total SO₂ and pressure above atmospheric.
- **3 labels** (with front and back labels).

In the following days, **Chardonnay du Monde®** will charge you for the transportation cost, in accordance with **SAQ Logistic/Chardonnay du Monde®** special offer (See page 4 of the registration form).

2 • DUTIES

No importation duty is involved provided the bottle unit value is not more than 1 €. The pro forma invoice (needless for EC shipments) must state the total value of your sample(s). In case the value is higher, or if the shipment value exceeds 22 € (22 USD), **duties will be charged by France customs, and Chardonnay du Monde® will add these extra charges to the transportation price.**



Caution: Extra custom costs, taxes and duties will be charged if the value of your shipment exceeds 22 euros.

3 • PACKAGING

We strongly advise you to pack your bottles in polystyrene boxes, which restrict the risk of breaking. Wooden boxes should not be used as there is a greater risk of damage. The invoice will be issued according to the weight indicated on the shipment.



Caution: shipment charges are based on either volumetric weight or actual weight, whichever is greater.
